Mission-*To mobilize people for their self-development, providing information facilities and building capacities so that they move on the path of development on continuous basis.*

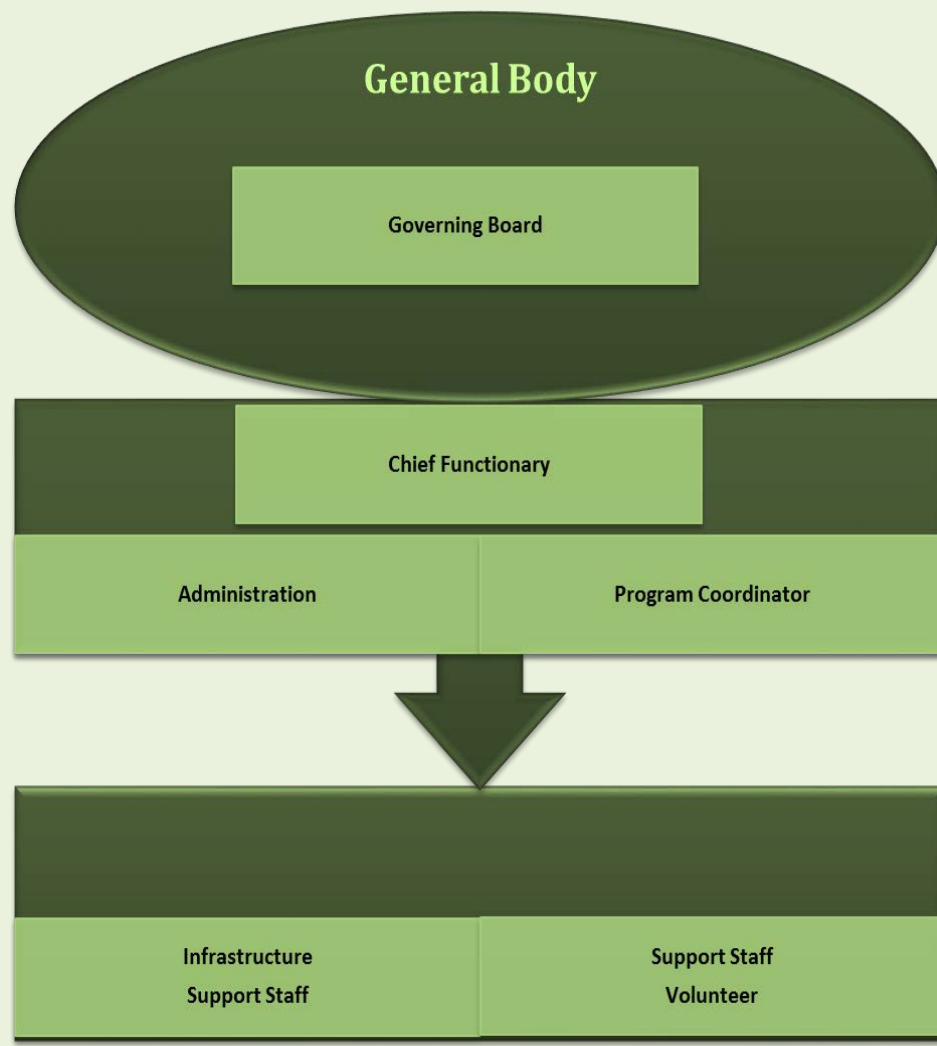
Area & Issue where we work

Parhit is working with Sahariya tribe, Dalits(Jatav,Chamar,kori,lodhi), and some of the most marginalized communities in 7 districts (*Datia, Shivpuri, Guna, Sheopur, Sagar, Chatarpur and Tikamgarh*) in the state of Madhya Pradesh. Together these districts form one of the most backward regions not only in Madhya Pradesh, but also in India. Using right based approach, Parhit aim to mainstream socially, economically, and educationally deprived section of the society so that their capacity can be build and they can access their rights and entitlements. With these sections of the society, Parhit work on

- Ensuring Right to food, work & sustainable livelihood.
- Addressing drought and distress migration.
- Right to Education with focus on dalits and girl child.
- Eradicating violence against women and adverse sex ratio.
- Right to life and dignity for people suffering from ailments such as HIV/AIDS.

Strengthening Quality Of Life through Sustainable Livelihood-

Ensuring food security and sustainable livelihood among sahariya tribe through better implementation of govt. flagship scheme.

Since April 2015, with help of Bharat Rural Livelihood Foundation (BRLF) a consortium of 4 organizations Parhit, Kalptaru, Dharti and Niswath has been working to improve the overall quality of life for Sahariya community. Parhit is the lead agency for the project and intend to reach out to 5827 household in the project duration of five year. 65 villages has been covered by us during 2015 to 2017.



Aim

To improve the overall quality of life of Sahariya community

Objective

- To empower Sahariya Community through creation of sustainable livelihood options and alternatives
- To enhance minor forest products (MFP) collection methods and develop linkage with markets for MFPs
- To sensitize Sahariya women through formation of Self Help Groups, covering 60% women in targeted villages
- To strengthen and facilitate the Panchayati Raj Institutions (PRIs) and Community Building Organisations (CBO) for extending the benefits of Govt. Programmes and welfare schemes
- To ensure better coordination among Government line departments

Childline India foundation selected ParhitSamajsSeviSanstha as Collaborating partner. The project is operational in Shivpuri district since September 2012.

Establish a child-friendly society that guarantees the rights and protection to all children.

To reach out to every child in need and ensure their rights and protection through three Cs-

- COMMUNICATE to make child protection everybody's priority.
- COLLABORATE through integrated efforts between children, the state, civil society, corporate and community to build a child friendly society.
- CATALYSE systems through active advocacy.

(2) Summer Camp for Destitute Children:- Date 17th - 24th June, 2017. Camp conduct in Govt. Boys Hostel at MadhawChauk Shivpuri. The camp Objectives of *To entertain the destitute children.

- To provide an opportunity to the children to express themselves and their efficiencies.
- To encourage the children about education and health.
- To save the children from Child Labour and Child Marriage.

(3) The "PARVARISH YOJNA" Start July 2017 by Collector distt. Shivpuri for Orphan Children. 95 children benefits received in this **"PARVARISH YOJNA"**.

(4) Block Label Convention: - A Block Level conference was organized on **The Role of Youth in the Protection of Children** in Community Hall, Shivpuri on 8th October, 2017. The conference was organized by the joint participation of District Child Protection Unit, Unicef Bhopal, ParhitSamajSevaSanstha, Shivpuri.

Total 305 young men and women were participated in this Block Level Conference from various 30 villages of Shivpuri Block.

The main objectives of this conference were:-

- To improve the understandings of youth on the issues of Child Protection and to join them to it.



- To create a pressure group for the advocacy of the issues of child protection from village level to block level.

(5) Railway Child Protection Committee formation: -on 11th January 2017 Railway Child Protection Committee formation distt. Shivpuri. Herein 11 Members.

CASE STUDY

Case ID:- SHIV/62228/9th March 2017

Name of the child – AneetaAdiwasi

Age – 16 years

Mother's name – Mrs. Meena Adiwasi

Father's name – Mr. Punjab Adiwasi,

Address – village Bhangarh, Block Shivpuri, Distt. Shivpuri (M.P.)

On 9th March, 2017 During outreach in Village Subhashpura, CHILDLINE team found a child AneetaAdiwasi, Age 16 years, father's name – Punjab Adiwasi, mother's name – Meena Adiwasi, native of village Bhangarh, Block Shivpuri, Distt. Shivpuri (M.P.), was weeping at Bus Stand. CHILDLINE team member Sangeeta talked to the child and asked her problem. She replied that a boy had misdeed with her. She went to Police Thana but police is not lodging the FIR against the boy. CHILDLINE counselor counseled the child.

All the information was delivered to Mr. Navi Ahmad Khan, Center Coordinator CHILDLINE Shivpuri. As per his instructions, CHILDLINE team talked to the child and her father and noted their statements. Child told that she went to graze the goats to the forest. Then, the boy Rudra Adiwasi S/o Uday Adiwasi came to her and misdeed with her. The accused Rudra Adiwasi S/o Uday Adiwasi age 21 year her neighbor. He threatened her and told her to not to say anybody. On 8th March, 2017 he tried to misdeed with her again. But she ran away from there by hitting him. Then, She told to her sister about that. Then, they came here to lodge the FIR. But police is not lodging the FIR.

Then, CHILDLINE team took the child and her father to Subhashpura Thana. CHILDLINE team met to Thana In-charge Mr. Ashish Khanna and discussed about the case. Then, he lodged the FIR against Rudra Adiwasi, U/S :- IPC – 376, 506 and POCSO Act – 3/4 After that, Police immediately went to village Bhangarh and arrested the convict.

After that, child was taken to Community Health Centre, Satanwada. There, her medical checkup was done by lady doctor.

All the information of the case was delivered to Mr. Amit Sonavale (CIC, CIF Mumbai) and Ku. Shalini Diwakar (City Coordinator) by Mr. Navi Ahmad Khan (Center Coordinator).

On 10th March, 2017 child and her father came to CHILDLINE Office. Center Coordinator talked to them and counseled them. After that, they were produced to Child Welfare Committee. CWC Member, Mrs. Uma Mishra counseled the child Aneeta.

After that, child was taken to District Court, Shivpuri. There, her statement was taken by Judge under the section 164.

This information was also delivered to Mr. Amit Sonavale (CIC).

At present time child is living at her home with her family. And convict was arrested and was sent to the prison.

Drought Resilience & Water Conservation

Peoples' control over resources like land, water, forest, coast, minerals, commons and livelihoods.

Action Aid took initiative to work for mitigating the impacts of drought. In the work, six block of Bundelkhand region were covered - Jatara and Nimadi block of Tikamgarh district; Lavkushnagar, Wakswaha, and Rajnagar Blocks of Chhatarpur district; and Wanda block of Sagar district. This project continues since 2009.



Aim

To make Bundelkhand Drought free.

Objective

- To undertake steps aimed at water storage and conservation.
- To make community based organizations and link them with government flagship schemes.
- Demonstrate small scale organic agriculture model.
- Help in establishing public rights organization.
- People were connected with the scheme MNREGA, Agriculture's scheme, Horticulture's scheme, Atma Department's scheme for non pesticide agriculture/ traditional agriculture, social security pension, PDS etc.

Programme- Ensuring Education and Protection Right (Including Prevention of Child Marriage and Sexual Abuse) of Children and Adolescents in

Parhit Sanstha has been working with **UNICEF** Bhopal since 15 October 2014 in 30 Villages of Shivpuri district. In the project, work on creating awareness on the educational criteria specified under Right to Education Act was carried out. Work with the community for child safety and rights were also carried out. With the help of government; Anganwadi, Sarpanch, ANM, Teacher and Education Department were also made aware about child rights.

Objective

- Create awareness on child education, and security with the support of government, ANM, Sarpanch, Teacher, and Education department.
- Establish child security committee in each village
- Make youth committee in every village, organize child right awareness campaigns
- Ensure availability of playgrounds for children to play
- For right to education organize conferences, meetings, trainings, wall paintings, and group discussions.

National health mission-this programworking in two blocks of Tikamgarh district one is Niwadi and second is Badagaon. Aim of this program is decreased infant mortality and maternal mortality by awareness of health environment. In this program we provide training for Asha so that they can aware women by plays and picture. That motivational picture for healthy diet, promote delivery at hospital and proper immunization of child and pregnant women. Also this PLA (Participatory Learning Appraisal) organize by trained member who

organize meeting with community women and aware them for proper healthy diet and for women/child immunization.

CASE STUDY

62 FAMILIES GET RESIDENTIAL PATTE UNDER FRA

This story of 62 families who got residential patte after long struggle. The story of villagers of vinega (that village part of BRLF program) a behind of that achievement is, a monk name is baba patharanand who came in vinega village before 10 year. Villagers of vinega village gave him a very small land for living. That small land converted into ashram of 100 acres. And baba patharanand did not let them do such activities like bhajan, puja construction etc. villagers of vinega was facing very terrible situation because baba parthranad is powerful person. Villagers couldn't do anything against him. Then one day a community meeting organized by Parhit sanstha. People of vinega were present there and raise that issue they told that baba don't let us do construction, bhajan,puja and any other function what we do no one listen our voice please help us if you can do. Then parhit organization's member assured them we will you, but we need your help in this case then villagers told definitely we will help you. Campaigns



started by parhit for FRA form filling and collect related documents like Adhar card, ration card, voter id etc. 62 form completed with documents. That application passed by forest right committee. On 26 January 2017 during gram sabha residential claim application present front of surpanch and secretary after that ,that applications passed by gram panchayat and send to next level process. After sometimes a 32 application sanctioned under PM awas for home construction villagers was very happy with news and started work of construction. One month latter baba

Patharanand complain of villagers they are doing illegal construction that land's owner is paramhansa ashram. Then villager's memorandum present front of Shivpuri collector. After collector's order residence construction again started. Then Patharanand did appeal in Gwalior high court with wrong information villagers doing illegal construction on forest land. Because new collector did not aware about this case he stopped the construction. With village animator Parhit organization made 62 domicile certificates and they won that case from Gwalior high court. One more obstacles created by baba, he complained to N G T. then collector of Shivpuri present their report and give them clearance regarding construction of residence.

After long struggle vinega villagers got residential patte and they building up their home.

Seed bank

A story of intervention in the field area of Parhit, Shivpuri. After BRLF workshop Bhopal Secretary of Parhit organization decided we will establish seed bank in our working area so that sahariya community take benefit of that bank and can do agriculture with our support.

With the aim of community welfare seven grain bank has been established in the month of August to September. Only few farmer do agriculture among sahariya community because they don't have sufficient resources for agriculture like seed, water, compost etc. in the month of August we met with villagers and discussed about seed bank which they want for rabi crop than we collect four type of seed such as local wheat, Mustard and gram also distributed one box for each village in that box four type of seed we can store. Kalothara, Barain, Piproniya, Khajuri, Imiliya and Kotka in these village we established seed bank.



Purpose of seed bank establishment-

- Conservation of local and traditional seed.
- Organic and non pesticide seed.
- Connect others farmer with this intervention.
- Availability of seed.

Scroll for seed bank-

- 10 members committee built for seed bank in which leader, treasurer and secretary.
- Committee will collect seed for rabi and kharip crop.
- The person who is taking seed from that bank he has to ensure for return after production.
- Every member of that bank given 100 rs that amount use for buying seed for next season's crop.

95 farmers has been benefitted by that bank we are ensure next season crop more and more farmer will be part of that intervention.
